Preamble

The Right to Information Act 2005, intends to set out the practical regime of Right to Information of citizens to enable them to access the information under the control of the publicauthority to promote transparency and accountability in the working of such authority.

Section 2(h) of the Act defines "public authority" as any authority or body or institution of self-governance established or constituted -

- 1. by or under the Constitution;
- 2. by any other law made by the Parliament;
- 3. by any other law made by State Legislature;
- 4. by notification issued or order made by the appropriate Government and includes any
 - body owned, controlled or substantially financed;
 - non-government organization substantially financed, directly or indirectly byfunds provided by the appropriate Government.

Following the provisions contained in section 2(j) of the Act, "Right to Information" means the right to information accessible under this Act which is held by or under the control of any publicauthority and include the right to

- 1. inspection of work, documents, records;
- 2. taking notes, extracts or certified copies of documents or records;
- 3. taking certified samples of material;

 - viii. A statement of the boards, councils, committees and other bodies consisting of two or more persons constituted as its part or for its advise, and as to whether meetings of those boards, councils, committees of such meetings are accessible for public;
 - ix. A directory of its officers and employees;

If however, eligible candidates are not available in one of those categories, both the representatives may be taken from the other.
- 2. Principal: The Governing Body appoints a full-time principal on the recommendations of the Selection Committee appointed for the purpose, with the approval of the University of Kota.
- 3. Teaching staff and librarian, appointed by a duly constituted Selection Committee.
- 4. Non-teaching staff appointed by a duly constituted Selection Committee.
